- Definitions: "modernArtistry.com" refers to the business of modernArtistry.com. "Client" refers to the commissioning party or company named above, its representatives, or successors.
Meal: Client shall provide DJ with a meal equal in quality and portion to that of your guests. Lesser quality "vendor meals" or "sandwiches" are not accepted unless they are the same meal as your guests or of similar quality.
Timing: All contracts are up to 5.5 hours of DJ time unless otherwise stated above.
DJ Overtime Rate: \$400.00 per hour, billable in one hour increments only or at the discretion of your actual DJ, and may be paid the day of Event or within two weeks of your Event date. Cash, checks, or credit cards accepted - Client must contact dave to complete credit card transactions.
Contract Payment: Full payment must be received by the 7th of the month, one full month prior to actual event date. Please make checks out to "dave donato" or "modernArtistry.com".
DJ Time: DJ agrees that at no time shall a break will be taken which would cause the music to cease. Music will continue playing during any meal breaks taken by the DJ.
DJ Table and Electricity: Client / Venue is responsible for providing a suitable table for DJ equipment, as well as an appropriate electrical source (one 110v outlet is usually sufficient).
Outdoor Events: Outdoor events require the client to provide the DJ an overhead structure such that the DJ and all equipment is protected by sun, rain, and/or similar weather. Failure to provide such protection could result in the DJ needing to cancel their work until such protection is provided.
Event Cancellation: If at any time the above Event is canceled, money received" is non-refundable and held as a credit for a period of 3 years of contract date, minus \$250 (" \$250 non-refundable fee to Artist for previously holding the canceled date). Balances are transferable by permission and proper paperwork transfer.
DJ Cancellation: In the event that your DJ cannot attend your Event in full as contracted, modernArtistry reserves the right to find a suitable replacement DJ within our company, or through our outside network of professional contacts. Client does retain the right of refusal of our replacement DJ. If a replacement DJ cannot be agreed upon, all money paid by client for the original DJ will be refunded within 90 days of Event date.
Client Default: In the event of non-payment or other breach of this Agreement by Client, Client shall pay all of modernArtistry.com's costs and expenses incurred in connection with enforcement of the terms of this agreement, including reasonable attorney's fees.
This agreement shall be deemed to be a contract made under the laws of the United States of America and the State of Massachusetts and for all purposes shall be interpreted in its entirety in accordance with these laws. In the event of any award or judgment in favor of modernArtistry.com, or any settlement between modernArtistry.com and Client, arising from effecting and protecting modernArtistry.com's rights and benefits hereunder, Client shall pay all costs and expenses incurred by modernArtistry.com and/or modernArtistry.com's legal counsel related thereto, including, but not limited to, reasonable legal fees, arbitration and court costs, associated expenses, and legal interest on such award, judgement, or settlement.
