RELEASE OF LIABILITY, WAIVE OF CLAIMS,

BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS,  
INCLUDING THE RIGHT TO SUE

ASSUMPTION OF RISK:

- 1) I, the undersigned, wish to participate in the "BORDER WARS" event. I recognize and understand that participating in the "BORDER WARS" event (hereinafter called the "Event") involves certain risks. Those risks include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the event and injuries from tripping or falling over obstacles in the event playing field. There may be some physical contact, involving the use of foam, rubber and latex props, smoke grenades/pyro, as well as the use of 6mm plastic projectile airsoft guns. In addition, I recognize that the exertion of playing the game could result in injury or death.
- 2) Despite these and other risks, and fully understanding such risks, I wish to play the Event and hereby assume the risks of playing the Event. I also hereby hold harmless Brandon Stewart, Matt Adamczyk, Frontline Simulations (Milsim) and its Staff, and all associated volunteers and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including attorney's fees and expenses), damages and liabilities arising out of, connected with, or resulting from my playing the Event, including without limitation those resulting from the manufacture, selection, delivery, possession, use or operation of such equipment. I hereby release Brandon Stewart, Matt Adamczyk, Frontline Simulations (Milsim) and its Staff, and all associated volunteers from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives, and assigns. I hereby certify to the sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to Brandon Stewart, Matt Adamczyk, Frontline Simulations (Milsim) and its Staff, that I am in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in playing the Event, I further certify that I am 18 years of age or older.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of participating in the "Event", I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against Brandon Stewart, Matt Adamczyk, Frontline Simulations (Milsim), their directors, officers, employees, agents and representatives (all of whom are hereinafter collectively referred to as "the Releasees");
2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my participation in the "Event" due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage to property of, or personal injury to, any third part, resulting from my participation in the "Event"; and
4. That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death.

I HAVE READ AND UNDERSTOOD THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
